

**PRIVACY POLICY NEWSLETTER**

**Pursuant to Reg. EU 2016/679**

In connection with the processing of the personal data provided, please note that:

**1. Data Controller**

The Data Controller is the company Chimar srl, with registered office in Cadoneghe (PD) via E. Majorana n. 24 - 35010, tel. 049 8885211, e-mail [amministrazione@chimar.com](mailto:amministrazione@chimar.com), pec (certified e-mail address) [chimar@cert.neispa.com](mailto:chimar@cert.neispa.com) (hereinafter referred to as "the Company" for brevity)

**2. Type of data processed, Purpose of Processing and Legal Basis**

The following personal data are collected and processed: personal data of a common nature (first name, surname and e-mail) relating to customers, potential customers, users for the purpose of sending newsletters containing updates on the activities and products offered by the Company. The legal basis for data processing is the consent of the data subject.

**3. Communication of data to third parties - Data recipients**

The Company may disclose the data processed for the above purposes: to the internal staff in charge of managing newsletters and commercial and promotional communications; to external communication companies/ companies that provide the service of sending newsletters.

**4. Transfer of data to third countries**

The processed data may be transferred by the Controller to third countries for the above-mentioned purposes. However, in the event of the transfer of data to such countries, this shall take place in compliance with the regulations in force from time to time on the transfer of data to third countries pursuant to Article 44 et seq. of GDPR 2016/679.

**5. Processing methods, data retention period and criteria**

The data will be processed digitally until revocation or deletion by the data subject, and in any case a new consent will be required two years after the consent was given. At the end of this period, the Controller will either request further consent or delete the contact.

**6. Rights of the data subject, Withdrawal of Consent and Complaint to the Supervisory Authority**

The data subject, if the legal requirements are met, has the right at any time to request access to his or her personal data, to have it rectified, erased or restricted, to object to its processing and to exercise the right to data portability.

In any event, the data subject has the right to revoke at any time any consent given to the processing of data, without prejudice to the lawfulness of the processing based on the consent given before revocation.

In the event of an alleged breach, the data subject, if the conditions are met, also has the right to lodge a complaint with a data protection supervisory authority located in the EU Member State where he or she normally resides or in the EU Member State where he or she works or where the alleged breach occurred.

**7. Provision of data**

The provision of data is optional. Failure to provide data will make it impossible to pursue the above-mentioned purposes.

**8. Profiling and automated decision-making processes**

Processing is not carried out by means of automated decision-making processes.

**9. Contacts and requests**
